3.	Booking of Peres Center	Nil	This has to be done by Event Production Agency. Peres

4.	Arrangements for Yoga Mats	Nil	Not part of scope of work. Mats would be arranged by Indian Cultural Center/participants.
5.	Event open to general public or is there a specific guests list?	Nil	The event of International Day of Yoga is OPEN TO ALL subject to capacity of the venue i.e. 300 participants.
6.	Event registration management	Nil	Due to the restriction of 300 participants, prior registration for participating in the event is required and it should be done by Event Production Agency through channels such as EventBrite.
7.	Stage requirements	Nil	Sufficiently large stage to accommodate dignitaries on the stage for speeches as well as provide space for Yoga demonstration by 8-10 people.
8.	Water, Food and Beverages	Nil	This will be arranged by Embassy of India therefore, not part of scope of work of Event Production Agency. The space for keeping the water, food, beverages and distribution of souvenirs, etc. shall be arranged by the Event Production Agency.
9. Kindly note that quality of photographs and videos taken by Event Production Agency should be of good quality and these should be delivered to the Embassy of India on the SAME DAY after the event.
11.	Queries related to publicity	Nil	There is no separate PR agency hired. Embassy of India expects that selected Event Production Agency should work in collaboration with Embassy to promote the event to increase awareness among people of Israel pre-event. The Event Production Agency may also publicize the event through appropriate use of social media/websites having wider access to Israeli audience to ensure adequate pre-event publicity is done among the people of Israel. In addition to this, Embassy of India would also publicize the event through its social media handles.
12.	Branding and design	Nil	Event Production Agency is expected to do design and branding for the event with necessary approval from Embassy of India.
13.	Place of the main Projection Screen(s)	Nil	Placement of main projection screen can be as stage backdrop and in addition, a side screen may be arranged.
