#### Scope of Work

The detailed scope of the cleaning work of the aforementioned office premises of Embassy of India Tel Aviv have been given in Annexure 'A'. A contract will be signed between the selected firm and the Embassy of India, Tel Aviv in the format of the agreement given at Annexure 'B'.

### Eligibility Criteria

The Firms submitting bids should have experience of at least 3 years in the above business and must be registered with the relevant Israeli government offices as is required under the local regulations for tax and other purposes.

### Other terms and conditions

- i. The cleaning work should be done as per directions of Embassy from time to time.
- ii. The contract will be initially signed for one year with a provision that the agreement can be extended for a further period of two years with the same terms and conditions on mutual consent.

- iii. The rates finally approved/accepted by the Embassy, including the VAT amount payable shall be valid for the contract period and no upward revision will be allowed under any circumstances. Embassy will not entertain any claim on account of any tax other than VAT for execution of the work awarded under the contract and all such taxes should be paid by the firm itself.
- iv. Under no circumstances shall the successful firm appoint any sub contractor or sub- lease the contract. If it is found that the contractor has violated these conditions, the contract will terminated forthwith without notice, by the Embassy.
- v. Delay in work will not be permissible on the grounds of non-availability of the materials, items etc.
- vi. Late submission of bids due to any reason, will not be accepted/ considered under any circumstances.
- vii. The contract can be terminated by the Embassy at any time if the work of the contractor is found unsatisfactory.
- viii. The bills for the services for a month must be prepared on the basis of approved rates and submitted to the Embassy by the 10<sup>th</sup> of the succeeding month for effecting payment.
- ix. No advance payment shall be made for the services.
- x. The Payment will be released through direct bank transfer or through a crossed check in the name of the firm.
- xi. The job carried out shall be to the satisfaction of the Embassy.
- xii. The contract can be terminated by giving a 60 day notice by either side.
- xiii. Substitute should be provided in case non-availability of regular cleaning staff.
- xiv. The company should provide details of cleaning staff to be engaged by the company for cleaning work in the Embassy.
