## Important Instructions for Passengers Planning to Travel by New Delhi - Tel Aviv Vande Bharat Mission Flight scheduled for 25 August, 2020

### Eligibility:


- Israeli National Passport Holders are allowed to travel on this flight.
- Non-Israeli Nationals (including Indian nationals with valid work permit/visa) <u>can travel from New Delhi to Tel Aviv only if</u> they have letter from Population and Immigration Authority of Israel, Border Control Division allowing them to travel to Israel. This letter has to be presented at the time of check-in in order for them to be accepted on this flight.
- All passengers who are accepted on this flight will have to undergo mandatory quarantine of 14 days in Israel.

### Procedure for Booking the tickets on this flight:

- Ticket for this flight would be available for sale online only through the Air India Website <u>www.airindia.com</u>
- Online ticket sales will start on <u>10 August 2020</u> from time <u>0930 hrs</u> (Israel Daylight Time) or <u>1200 noon</u> (Indian Standard time).


### Process flow for booking tickets is placed below:

#### Please note the following with regard to the Baggage allowance:

- Only one piece of handbag not weighing more than 8 kgs is allowed to be taken as hand baggage for both Economy and Business class passengers. This allowance includes the laptop bag.
- In the Economy class, two pieces of checked-in baggage not weighing more than 23 kgs each is allowed per passenger.
- In Business class, two pieces of checked-in baggage not weighing 32 kgs each is allowed per passenger.
- Air India does not have details of Hotels/Rates for quarantine requirements. The same has to be arranged by the passengers themselves.
